Saying yes and saying no

Skills for clinicians dealing with ethical dilemmas in medicine

In 1999 British forces were asked to occupy an airfield in Kosovo. But as the Russians had already occupied it, the General Officer commanding, General Sir Mike Jackson, refused to carry out the order. He was not willing to start a conflict between Russia and NATO. As their commander (who possibly risked reprisal for refusing to follow orders) said: "I'm not going to have my soldiers be responsible for starting World War III". Singer, James Blunt, who was a 25-year-old cavalry officer at the time, was one of the commanders initially ordered to the airfield but he later said "There are things that you do along the way that you know are right, and those that you absolutely feel are wrong, that I think it's morally important to stand up against, and that sense of moral judgement is drilled into us as soldiers in the British army". Although both had technically defied military orders during combat, neither faced any reprisals because they were able to appeal to a higher law, both international law and the law of morality.

Doctors and nurses often face ethical dilemmas which means that, sometimes, they find themselves in a position that risks career and family welfare in order to do what is right. This is especially true when they stand against some fashionable, but defective, medical opinions. So far, the greatest pressure points have tended to arise when dealing with abortion, contraception, some fertility treatments and care of the elderly and dying.

It is important to know what is right and wrong, but clinicians must also be able to defend their clinical and ethical decisions and to communicate those decisions, and the reasons for them, effectively and compassionately. If clinicians cannot do that, their jobs may be at risk.

Rather than focussing exclusively upon the discussion of what is ethically right and wrong, this conference will work to provide ideas as to how health workers might meet the ethical and clinical challenges without putting their careers at risk and how they might do so practically. Questions that often arise include asking how clinicians communicate a negative decision responsibly, ethically and compassionately or how they professionally argue for the provision or continuance of good care when others may be reluctant to treat. Topical areas include advice and professional decisions relating to difficult pregnancies, fertility care, nutrition and hydration, care of the elderly, and disabled, among other areas.

In this conference experienced and expert speakers will work with delegates to set out appropriate and well-informed professional methods of advising, deciding, communicating, discussing and negotiating, with the aim of building up the skill-base of participants. The conference will make use of workshops and experiential learning to support participants who will be a mixture of young and more experienced clinicians coming together to share and develop skills and knowledge.
